

WE ARE IN THE PROCESS OF A CONVERSION... WHAT DOES THIS MEAN FOR YOU?

PALCO is making technology enhancements designed to give you, our members, an even stronger foundation for your financial wellbeing. We are excited to announce that we are converting to a newer, more efficient computer core processing system. This will take place on June 1 & June 2. The new core system will help us operate more efficiently and continue to provide you with safe, secure products and services.

What is a core processing system? The core system is the software that manages our primary banking functions. While our core conversion will mostly happen behind the scenes, it may affect some of the services you may use.
